## General Terms and Conditions Gyeong-rye / Taekwondo The Hague

### 1. Registration

- 1.1 All fields must be completed clearly and legibly. (please in capital letters).
- 1.2 When registering a minor (up to 18 years), the form must be signed by one of the parents/guardians.

### 2. Semi-annual membership fee and payment:

- 2.1. When entering into membership, you must transfer the membership fee with a (one-off) registration fee upon registration to our bank account. The five-monthly installments must be paid no later than on the following dates:  
**Membership fee for September to January: August 25, prior to this term;**  
**Membership fee for February to June: January 25, prior to this term.**
- 2.2 Gyeong-rye reserves the right to increase the membership fee annually.
- 2.3. If a member does not meet its payment obligations on time, a reminder will be sent twice. If after the second reminder, the payment obligation is not complied with, the claim will be handed over. All costs incurred for this are at the expense of the member.
- 2.4. If the payment obligation has not been met, the member can be refused access to the training.
- 2.5. Gyeong-rye is entitled to terminate the relationship with the member in case of payment arrears, without the payment obligation lapses.

### 3. Cancellation

- 3.1 **Cancellation must be made in writing.**  
This can be done via the website, email or by (registered) post; c/o Zuilensteinstraat 7 2596CA The Hague.
- 3.2. Through a confirmation of the cancellation, Gyeong-rye will terminate the membership on the specified date; as long as the membership has not been terminated, the member remains liable to pay the membership fee.
- 3.3. Upon termination of membership, a notice period of 1 month applies.
- 3.4. Without cancellation, the membership is automatically renewed; the contribution obligation remains until the moment on which the contribution has been paid and the cancellation of the membership is effective.
- 3.5 If you are unable to attend, no refund will be made for that month or a proportionate part thereof.  
The board can grant exemption from monthly contribution if this is announced in advance. Exemption will never take place if this is made known afterwards.
- 3.6. Gyeong-rye reserves the right in case of serious or repeated violation of the house rules or other evidently unacceptable behavior, to terminate a membership at the trainer's request without refund of payment and without the payment obligation for the current year lapses.

### 4. Membership TBN (Taekwondo Bond Nederland - Dutch Taekwondo Federation)

- 4.1 When registering as a member, one is obliged to enter into a membership of the TBN, the umbrella organization in which Gyeong-rye (club no. TV110170) is affiliated.  
This membership is an agreement between the member and the TBN and can only be terminated by the member himself.

### 5. Liability

- 5.1. Participation in training and activities is at your own risk. Gyeong-rye is not liable for any injury(s) as a result of accidents during participation in the training courses and activities. Everyone takes the lessons at their own risk.
- 5.2. Gyeong-rye and her trainers/volunteers cannot be held responsible for damage, loss or theft of property in any form.
